The responses are vaguely consistent from the college board, since they are accredited for the format of the test, and yet the public's ultimate dissension regarding the reliability of the SAT is rapidly becoming an apparent issue. According to a Stanford Education analysis of the SAT role in America's higher education titled Admission Testing in America: "At selective colleges where there are far more academically capable applicants than can be admitted, the admission officers choose ap-

plicants who fall into one of four categories; applicants who are academically exceptional; those that have a diverse background, experience, or talent; students likely to contribute valuably to society or their profession; and applicants

Yet the SAT continues to serve as a requirement for California Universities and seems fortified with state-wide support; immune from existential threats and elevated by the College Board. However, the requirement has

that have a strong loyalty to their institution." The populist ideology behind the SAT has leaked into many arguments that the SAT is a "privileged test" and is heavily influenced by the socioeconomic background of the test-taker-such as high school education, communities, and household poverty. This is self-evident in the College Board's appeal for an adversity score that would quantify the socioeconomic factors of a student's environment.

come under fire from lawsuits filed on behalf of the Compton School District, by several plaintiffs last year. According to a reportive article titled "UC violates civil rights of disadvantaged students by requiring SAT for admission, lawsuits say" from the Los Angeles Times: "The lawsuits allege that UC's testing requirement violates the California Constitution's equal protection guarantees and bans on discrimination by state education and civil rights laws." The plaintiffs argued that the contending requirement of the SAT as a distinctive and deciding factor for college admissions in University of California schools with more than 300,000 students and several campuses, violated the student's right if they possessed a disability protected under a code of law in California's constitution. However, this anticipated lawsuit is unparalleled to prior lawsuits, but substantially magnifies the 'complex issue" of socioeconomic factors and its dramatic impact on this standardized test. The architects of inter-

collegiate admissions and its corollary factor of the SAT may not have envisioned the dilemmas that have sprouted from this single stratification in college admissions. This test is a universal tool for colleges in America to measure student's academic preparation but this is not fairly taken by students because their socioeconomic status and academic resources are biased elements of this dilapidating test. Whether the elimination of the SAT is a legitimate option in holistic admissions in the States or a diverged approach by admission officers to apply other crucial components of the application processes other than this standardized test, the palpable issue of its place in higher education will contend in the courts and demand attention from all whom this academic creed includes.





## A Deadly Tradition

In Nepal, the government has struggled to end the use of 'period huts,' or small shacks, where women are sent to live when they are menstruating. According to

HuffPost, this practice, known as Chhaupadi, was outlawed in 2005. Unfortunately, as of yet, the law has been unable to eliminate period huts, and until recently no one had ever been arrested for forcing a woman to use a period hut.

Parwati Budha Rawat, a 21-year-old woman from the district of Accham, was found dead on December 2. She had been exiled to a period hut, and in an attempt to keep herself warm during the freezing night, she lit a fire and suffocated from the smoke. Her hut had been windowless and thus had allowed for little to no air ventilation.

HuffPost states that her brother-in-law, Chhatra Rawat, was questioned and arrested to determine if he had forced her to stay in the hut. Chhatra may face a three-month prison stay and a fine of nearly 3,000 rupees

(26 dollars) if he is found guilty.

While the police are being applauded for Chhatra Rawat's arrest, many people believe that the Nepali government must enforce this law more strongly. According to CNN, despite the ban, at least 77 percent of women in Nepal practice Chhaupadi. These women face threats from not just the frigid weather and poor sanitation, but wildlife and other people. "The women and girls we spoke to were terrified of snakes and animals coming in at night, or of being attacked by strangers," explains Dr. Jennifer Thomson, as reported by EurekAlert. On top of that, 40% of the girls surveyed by the University of Bath weren't even aware that practicing Chhaupadi was illegal.

This tradition is even deadlier for women who do not have a hut to sleep in. In an article by EurekAlert, Dr. Thompson also added that "...if they did not have access to a chhau hut, or if it had been damaged or destroyed, we heard anecdotal evidence that women were often forced to sleep outside, open to the elements, or with animals."

The Nepali government has attempted to confront this issue from a different angle by giving a woman "a financial incentive of 5,000 rupees," if they refuse to enter a period hut, as stated by HuffPost. However, this monetary incentive is far from a solution. Many people believe that the government must be even harsher in its punishments for Chhaupadi crimes if the country is to eradicate the deeply ingrained practice soon

## White Island Disaster By Sonali Dhaliwal

Planet Earth is negatively affected each day by our actions. By the toxins that we put into the world using gasses and fires, we are limiting our time on Earth even more. Not only are these actions affecting humans, but animal life is also highly impacted.

Along with being one of the most popular tourist attractions, White Island is also one of the most active volcanoes in New Zealand. Although it is unfortunate outcomes include deadly emissions of sulfur dioxide and steam, explosive eruptions, boiling mud, mudslides, and tsunamis, the chances of an eruption is quite rare.

Authorities from New Zealand are opening up a criminal investigation into the deadly volcano eruption that left eight missing, including two children, and dozens injured. Currently, officials have reported 16 deaths. While 47 people were believed to be present on White Island during the eruption. This investigation will be centered on the safety of the tourists to be on White Island, during the time of the eruption. According to officials, hundreds of tourists were on or near the island during the eruption and had little to no warning. It was also very dangerous for rescuers!

The six bodies that were recovered Friday, were taken to Auckland where they had to undergo a detailed victim identification process. Many of the survivors were injured, with some suffering tragic burns, according to police. In recent updates, officials reported that 25 people are in critical condition. Ministry of Health officials officially confirmed 31 people were injured, including 25 victims which are now in regional burn units across New Zealand. The victims received burns covering more than 30% of their bodies.

Military specialists went through a four-hour mission, wearing breathing apparatuses and hazmat masks due to the treatment of toxic gas. A high quantity of ash and other various types of fallout from the eruption contami-

nated the water, and professional investigation divers were searching with barely any visibility. The contamination is requiring divers to take extra precautions to ensure their safety. They are beginning to use special protective equipment. The divers reported seeing a high number of dead fish and other animals washed ashore or floating in the water. The water is now very toxic to the remaining plants and animals in the area!

expected from such steam-driven eruptions are considered violent ejections ash. This is along with the formation of "hurricane-like" currents of wet ash and other harmful particles that are let out during eruptions. These can be highly deadly in terms of the impact of trauma, respiratory problems, and burns. The eruptions are usually very short, but once one takes place, there is a high chance for generally smaller disasters, as the system re-equilibrates.

Currently, the police are still undergoing further investigation. The main goal is for police to identify, find, and help more victims. So far, multiple people are still reported missing and search teams are on the hunt. Officials told the public not to go to the beach, or anywhere near the volcano, as it is still highly risky. Officials are asking for any sort of support the public may be able to offer. They are asking for assistance in searching, donations, and even just providing motivation. With this, a big difference can be made before it is too late. If actions are not taken, we and our future children may be very harmfully affected.

On January 3rd, 2020, President Trump ordered an airstrike on a convoy in Baghdad, Iraq, where Major General Qassem Soleimani of Iran was getting off an airplane. This strike was called for Soleimani's past actions and as a deterrent for any future actions that may cause harm to U.S. citizens. Soleimani controlled Iran's terrorist proxies, and was responsible for the use of advanced weaponry that killed hundreds of American soldiers. The U.S. called the strike to prevent actions like these from happening again. Iran has promised retaliation for these attacks, which has prompted Trump to tweet out that he would target 52 Iranian sites if they retaliated.

Just a few days later, on January 8, Iran sent a missile strike on a base in Iraq housing American troops. This missile strike reported no casualties, although it was later reported that the missile strike was sent with intention 'to kill.' This retaliation from Iran is a serious issue that can serve as reason for the U.S. to strike back, escalating conflict further, and potentially starting a serious war that could plague the countries for years to come.

This strike has been met with serious controversy. Many critics argue that the costs of this airstrike, like starting a serious conflict with a country with a lot of geopolitical power, outweigh the benefits. More people argue that the possibility of a draft will strike fear into qualifying Americans. The decision has been supported publicly by Mike Pompeo, the Secretary of State: "We are confident that the Iraqi people want the United States to continue to be there to fight the

counterterror campaign, and we'll continue to do all the things we need to do to keep America safe." The retaliation from Iran has led to speculation that a missile from the missile strike on the Iraqi base may have hit the plane, causing it to go down, further supported by

This severely impacts other regions, such as Mainland China because Hong Kong is known to be a major telecommunication hub. Ultimately, no one knows how it will end. The Hong Kong government and police forces have done little to calm tensions in the city and protestors have shown few signs of backing down, despite thousands of arrests.

**India:** In December, the anger over a new citizenship law led to chaos in more than a dozen cities. In response to the chaos and unrest, Prime Minister Narendra Modi, a conservative Hindu nationalist enacted a curfew, shut down the internet and deployed troops. This lead to violent police confrontations; fatally shooting several young men in Assam State,

disperse protests and the beating of unarmed students with wooden poles in New Delhi. In order to receive Indian citizenship, nativeborn citizens have to pass the citizenship test. According to the New York Times, the government had said the test was intended to

Incidents such as these are far too common in India, and many activists are demanding that both reported and unreported, CNN claims that India has not yet executed any convicted rapists. CNN states that only 28,000 of 117,000 reported rape cases were brought to trial in 2017. Kumari, a women's rights activist, declares to CNN, "The truth of the matter is that nobody gets punished." A harsher crackdown and enforcement of rape laws would, hopefully, deter many would-be rapists and save countless people.

a law that would help the president's bank account, or conducting a quid pro quo (an exchange) like Trump attempted to do with Ukraine from May 2019 to September 2019. Trump allegedly blocked Congressionally mandated military aid to Ukraine to investigate Joe Biden, a former Vice President and a potential, democratic presidential candidate. This action violated the Emoluments Clause and gave way for Democrats, who were looking for a reason to impeach Trump, to highlight these events and push the investigation. After all, this impeachment process is an important reminder to politicians and Americans that the government was broken into three branches to perform checks and balances on one another, making sure no one branch or person gets too powerful. To better understand the situation, let's take a deeper look at what happened. President Trump temporarily blocked four-hundred million dollars in congressionally mandated military aid intended to go to Ukraine, in hopes that Ukraine would help Trump investigate Joe Biden and his son, and hinder Biden's presidential campaign. Trump's exchange with Ukraine culminated in a July 25, 2019 phone call with the Ukraine president, Volodymyr Zelensky. As mentioned before, these series

ment watchdogs, almost immediately attacked the president's decision. Not too long after, Trump reversed his decision and claimed he was open to other options. It is unclear what Trump's intentions are exactly, but actions have shown ignorance regarding national law, and Congress calling him out on this breach of law. The impeachment trial lasted nearly three months from House Speaker Nancy Pelosi announcing the beginning of the investigation on September 24 to December 18, 2019 when the House deemed Trump guilty, making him the third president to be impeached in U.S. history. The investigation now continues in the Senate, where the articles of impeachment will be voted on to decide whether Trump will stay in office or be removed. So far, Senate Majority Leader Mitch McConnell (R-Ky.) has not confirmed a plan on how to conduct the trial. In addition, House Speaker Nancy Pelosi has said that she will not send the articles of impeachment to the Senate unless they have a clear plan for the trial. Despite all this drama, the impeachment trial is unlikely to pass in the Senate considering the Republican majority and two-thirds majority voting rule, which would allow Trump to continue his tenure in office without any major ramifications.




### America's Life Expectancy Plummets

While alive, Lil Peep started the "Emo Rap" trend amongst other SoundCloud artists, earning respect from another popular late rapper, Xxxtentacion.

## EST MOVIES BASED ON TRUE STORIES



Alta has about 550 inches of snow yearly, and on a given day, the mountain sees a base of 67 inches of powdery snow. Alta itself is a town with the mountains surrounding it. Alta is a skiing-only resort. There are 2,200 acres of skiable land, which a large amount It is also close to Salt Lake city allowing there to be a bus route to the capital city.

### 7. Steamboat Colorado

Steamboat gets around 154 inches of snow yearly, which is surprisingly low. Daily, there may be a

base of only 44 inches of snow. The resort has 2,950 acres of land to ski on. A special fact about this resort and area is that there are geological hot springs that you can stay warm and swim in. Steamboat is hard to get to, so it is not crowded during the weekdays.

### 6. Beaver Creek Colorado



Beaver Creek has a very fast ski lift. Beaver Creek also has almost always guaranteed perfect skiing conditions. The runs are more scenic compared to just plunging straight down a hill for speed. No towns are close by, but Salt Lake City is only about a 40-minute bus ride

4. Aspen Mountain Colorado

Aspen Mountain has four distinct sections that can be accessed on one ticket. The shuttle system takes skiers to any of the four destinations. The elevation is around 12,000 feet. The snowfall is not

The town around Aspen has tons of restaurants and entertainment options.

### 3. Vail Colorado



Vail has one of the best runs with great, wide and amazingly groomed snow. However, Vail is very expensive to stay at. The prices range from \$2,000 to \$8,000 for four days, and three nights. The town near the bottom of the hill is great because of the many entertainment spots and numer-ous five-star restaurants. Vail is the largest ski area with about 5,300 acres of skiable land.

### 2. Telluride Colorado



Telluride Ski Resort

Telluride has great powder snow. The resort offers many types of astonishing terrain. The snowfall in the area is around 300 inches a year, with about a base of 30 inches of snow on the summit regularly. The town is a six-hour drive from Denver. Telluride is a very expensive place to stay and ski. The price is about \$150 for just a one-day lift ticket.

Tom Kiefer is a janitor at a U.S. Customs and Border Protection facility near Ajo, Arizona. He has worked there for eleven years and is now displaying items that have been taken from people trying to cross the border. Migrants and asylum- seekers attempting to cross the border have some of their belongings taken because these items have been deemed potentially lethal or nonessential by border officials. Migrants are getting their medications, shoes,

They say a picture is Tom Keifer has been collecting all of their belongings for six years to create his photography exhibit "El Sueño Americano" (The American Dream).



Keifer's first experience seeing people's items being confiscated was when he became a janitor. Migrants would carry canned food that would be taken away. The food used to be donated to a local food bank, but, after being put under new leaderyears, I witnessed all this food being needlessly thrown out," Kiefer said. The next thing that caught Tom's eye was 15-20 toothbrushes, which he didn't think about photographing at the time, but just wanted to remove them from the trash. 

### USE GOOGLE LOCATION DATA TO FIND plications such as Google Maps

Every day, millions of people use google apps such as maps and gmail. Users usually believe that google wouldn't share their private information and it is safe with them. However, on May 20, before 5 p.m, a gunman went inside Call Federal Credit Union in Midlothian, Virginia, and pressured an employee to open a safe and escaped with \$195,000. The bank's surveillance footage showed the man holding a mobile phone to his ear right before the robbery, a helpful detail that proved to be useful that led police to try out an inspection technique that is expanding in recognition among American law enforcement agencies.

Police had arranged for a search warrant to force Google to give the location details from every user that was within the surrounding area of the bank within the hour of the robbery. Results came back with 19 anonymous users, but police were able to lower it down to 9 users. The inspection technique is referred to as the geofence warrant. Virginia policed requested Google for extra data and more time. The police finally lowered it down to 3 users and wanted all 3 users account

warrants used are forcing technology companies to give the location of any users using its technology in a specific time and place.

come with a downside; users might get plucked up in the search just by "Merely using an Android phone, conducting an Internet search using Google, running a Google ap-

or YouTube, or even receiving an automatic weather update from an Android service," as Chatrie's attorney, Michael Price, wrote in an October motion. Individuals that are innocent can sometimes be unconstitutionally searched if they use google in specific times and places. Michael Price states "No valid search warrant would permit the police to search every house in a neighborhood or pat down everyone in sight. Yet, with a Geofence warrant, law enforcement can do just that." Over the years, technology accuracy has improved enormously. For example, the location data saved in Google's Sensor Vault is extremely more accurate than a cell site location data. Google can easily spot a person's location to around 20 meters, compared to the cell site location data is "a couple thousand meters," as court recorded mentioned. Okello Chatrie, 24, pleaded not guilty to the charges, but if convicted, he may face life in prison.

Taking private information from someone without consent is unacceptable, but in some situations, it's necessary. When trying to solve an important case such as this, it is necessary.


